INVITATION TO BID FOR ROAD MAINTENANCE WORKS FOR FY 2018/2019

Kenya Wildlife Service (KWS) has received funds from the Kenya Roads Board under Road Maintenance Levy Fund and intends to carry out routine maintenance of two roads as listed herein. Eligible contractors are those registered as road works contractors by the National Construction Authority (NCA) under the categories in the table below.

The scope of works shall be as described in the tender document.

- Eligible bidders must also submit the following among other eligibility requirements listed in the instruction to bidders;
The tender document must be accompanied by Original Tender Security of Ksh 150,000 (One hundred and Fifty Thousand Shillings only) issued in Kenya shillings or a freely convertible currency and in the form of bank guarantee or an insurance guarantee from PPRA approved insurance company/ deposit taking microfinance institutions, SACCO societies, Youth Enterprise Development Fund or Women Enterprise Development Fund in the standard format provided in the tender document and valid for a period of 120 days from the date of tender opening
- Bidders can only submit up to a maximum of One (1) bid. Bidders submitting more than one bid shall be disqualified. There shall be MANDATORY organized pre-tender site visit on the dates and time specified in the table above. Bidders shall assemble at the designated locations as indicated in the invitation to bidders.
- Bidders having ongoing works with KWS that have not been substantially completed will not be eligible for bidding in this tender and will be disqualified.
The bidders shall comply with all the instructions of the tender and particularly ensure that all the forms required are properly filled for completeness as Prequalification Checklist for Competitiveness and responsiveness.
- All the pages of bid document MUST be serialized. Bidders who fail to comply with this criterion will be disqualified.

All clarifications and/or amendments will be published in KWS website and Tenderers are required to check for any addendums or amendments in the course of the bidding period prior to the closing date.
