- 2. The **KENYA WILDLIFE SERVICE** now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria on required qualifications and experience of the firm are:
- i) Experience in the assignment, including technical and managerial capability of the firm.
- ii) Number of years in business working on the area of the assignment.
- iii) Reference to at least three assignments of similar nature and size carried out in the last **five (5)** years. Include persons or institutions and contact addresses (*phone*, *email*) who can be contacted on the same.
  - Qualifications and Experience of Key Experts shall not be included in the short-listing criteria. Key Experts will not be evaluated at the shortlisting stage.
- 3. The attention of interested Consultants is drawn to the following provisions that will be highlighted in the Request for Proposals to be issued to shortlisted firms.
- i) The Consultant will be expected to have no conflict of interest with other assignments or its own corporate interests and acting without any consideration for future work.

- ii) The consultant has no personal or business relationship with the Procuring Entity's senior management or professional staff.
- iii) A firm or an individual in the firm has not been <u>sanctioned</u> by the Public Procurement Regulatory Authority or are under a suspension or a debarment imposed by any other entity of the Government of Kenya, or any international organization.
- 4 Government-owned enterprises or institutions of Kenya Government, officials and civil servants and employees of public institutions may not eligible.
- 5. Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.
- 6. A Consultant will be selected in accordance with the methods set out in the Act and Regulations.

#### EXPRESSIONS OF INTEREST (EOI)- THE PROPOSED KENYA PARKS PROJECT

The National Treasury and Planning of Kenya has requested a financing of the Feasibility Study from *Agence Française de Développement* ("**AFD**") on behalf of the Kenya Wildlife Service (KWS), and intends to use part of the funds thereof for payment of the feasibility study for the Kenya Parks Project (KPP).

The Services of the consultant shall consist of

- (1) **a Feasibility Study** of a project whose aims are to enhance biodiversity conservation efforts, tourism as a contributor to the economy, brand parks distinctively, enhance financial sustainability and improve infrastructure within five kenyan national parks, as well as
- (2) **a project appraisal document**. KWS seeks funding support of Euro 25 millions from the French development Agency for Nairobi, Lake Nakuru, Mt Kenya, Meru, terrestrial National Parks and Watamu Marine National Park. The estimate of the feasibility study contract size is about 200 000Eur.

The project also intends to strengthen enforcement capacity to protect wildlife through building the KWS capacity and extending the digital radio systems to additional conservation areas. By supporting wildlife conservation and the transformation of KWS, the project will contribute to the following objectives.

- o Enhance financial sustainbility of KWS
- o Upgrade park infrastructure for rangers and tourists' experience as well
- Increase revenues from parks managed by KWS
- o Increase the benefits/services for populations neighbouring the parks
- o Strengthen law enforcement capacity of KWS
- Reverse and stabilise wildlife population and ecosystems including inside the parks, wildlife corridors and community conservancies in the project area, .

The areas to be covered by the study identified in the KPP Concept Note: Nairobi, Lake Nakuru, Mt Kenya, Meru, terrestrial National Parks and Watamu Marine National Park.

Eligibility criteria to AFD financing are specified in sub-clause 1.3 of the "Procurement Guidelines for AFD-Financed Contracts in Foreign Countries", available online on AFD's website: <a href="http://www.afd.fr">http://www.afd.fr</a>.

The Applicant shall submit only one application, either in its own name or as a member of a Joint Venture (JV). If an Applicant (including any JV member) submits or participates in more than one application, those applications shall be all rejected. However, the same Subconsultant may participate in several applications.

If the Applicant is a JV, the expression of interest shall include:

- a copy of the JV Agreement entered into by all members, or
- a letter of intent to execute a JV Agreement, signed by all members together with a copy of the Agreement proposal,

In the absence of this document, the other members will be considered as Subconsultants.

Experiences and qualifications of Subconsultants are not taken into account in the evaluation of the applications.

Interested Applicants must provide information evidencing that they are qualified and experienced to perform those Services. For that purpose, documented evidence of recent and similar services shall be submitted.

Determination of the similarity of the experiences will be based on:

- The contracts size; The contract is about 200,000 Eur.
- The nature of the Services :

The services required are i)

Elaboration of a project design and feasibility study and a project appraisal document (standard format and outline will be provided to the selected Consultant) for a project area of 5 National Parks and 1 marine park and surrounding corridors and buffer zones. The assignment includes review of the current situation and project environment in terms of institutional, environment and social issues in the project area; elaboration of project objectives; definition and detailed content of each project component and project activities, a project implementation structure and an environmental and social impact mitigation framework.

A concept note has been produced by KWS. All aspects of the concept note will have to be assessed in order to design a project which will enhance biodiversity conservation, revenue generation through tourism and KWS management.

- The technical area and expertise: park and financial management, infrastructures, anti poaching expertise, wildlife tourism, biodiversity conservation, local communities engagement environmental and social safeguards, gender study, the assessment of the project contribution to climate change, including identifying adaptation to climate change, and a rough estimate of mitigation benefits applying the FAO EX-ACT tool.
- The location: in the region (East Africa, Kenya), with KWS or similar agencies.
- The Client will also take into account for the evaluation of the applications the following items:

The proposed Project team must include the following expertise:

Specific experience of the Consultant relevant to the Assignment;

The Consultant must have:

Demonstrated experience in park management, wildlife tourism, biodiversity conservation and infrastructure projects, community engagement and environmental and social baseline and safeguards, Climate change and adaptation, GhG accounting, gender diagnosis, GIS mapping and spatial analysis including satellite imagery.

Demonstrated experience in supporting the implementation of internationally financed projects in the East African Region or Kenya, with KWS or similar agencies.

Demonstrated experience in feasibility study.

The assessment will be based on the information that each firm presented and no additional information on the firm's capacity and experience that was not provided in the Application and the EOI would be sourced. The Evaluation Committee members will then assemble as a team under its Chairperson, and collectively gave their assessments. Each Evaluator will complete his/her scores as on Table6A and B–Individual Evaluator's Scoring Sheets shown below following the guidelines shown on Table5-Evaluation Scoring Guide lines (sub-criterion). The scores in all the Table 6s from each Evaluator will be moderated by whole Evaluation Committee to ensure there are no "too high or too low scores" by any Evaluator and will be transferred to Table 7- Consolidated scores. The Evaluation Team will agree on a final Table 8- and the Applicants will be ranked, from which a shortlist will be made and summarized on Table 11 – Shortlisted firms, which will be the outcome of the assessment.
